# The Labour Law in the Italian legal market: structure, trends and specialisation

The practice represents one of the most strategic and resilient segments of the legal market. In a context marked by regulatory complexity, evolving industrial relations, demographic shifts, and recurring phases of economic restructuring, labour law has continued to play a central role in supporting businesses, public entities, and top management in navigating change.

The firms included in this analysis collectively employ 531 professionals dedicated to labour matters, confirming the scale and relevance of the practice within full-service law firms as well as highly specialised teams. Labour law, traditionally perceived as a practice closely linked to litigation and trade union relations, has progressively evolved into a multidisciplinary advisory function, increasingly integrated with corporate transactions,

restructuring processes, compliance strategies, and top management advisory. The data presented reflects this transformation and highlights the structural features that currently define the Italian labour market.

## Team structure and gender equality

From an organisational perspective, the labour practice in Italy is characterised by relatively structured teams,

with an average of more than 15 professionals per firm among the market leaders surveyed. One of the most significant findings emerging from the data concerns gender balance at the professional level. Female professionals account for 43,69% of the total workforce, with 232 women out of 531 professionals. This figure indicates a near parity between male and female lawyers within labour teams, positioning employment law as one of the most balanced practice areas in terms of gender representation across the Italian legal market.

However, this balance is not yet fully reflected at the partnership level. Of the 119 partners active in labour practices within the firms analysed, only 34 are women, corresponding to 28,57% of total partners. While this percentage is higher than in some other legal practice areas, it nonetheless highlights the persistence of a gender gap in access to senior and leadership roles. The data suggests that, despite a strong pipeline of female talent, structural and cultural barriers may still affect career progression within law firms. Addressing this gap represents both a challenge and an opportunity for the market, particularly in a practice area that is deeply engaged with issues of equality, inclusion, and workplace governance.

## Revenue trends

In economic terms, the labour practice continues to represent a stable and significant source of revenue for Italian law firms. The average revenue generated by labour departments during the last fiscal year amounted to 91.80 million (data expressed in aggregate index terms), with labour accounting for 14.89% of total firm revenues when boutique firms are excluded. This confirms labour law as a core practice area, often complementary to corporate, litigation, and restructuring services, and capable of generating recurring and counter-cyclical work.

Nevertheless, the market has experienced a slight contraction compared to the previous year, with a -1.90% variation in labour revenues. This marginal decline should be interpreted in the broader economic and geopolitical context, marked by slowing growth, inflationary pressures, and a cautious approach by companies toward discretionary legal spending.

## Client base: Enterprises as the core market

The distribution of labour revenues by client size further illustrates the role of employment law as a transversal practice serving enterprises of all dimensions. Medium-sized enterprises represent the largest share of labour

revenue, accounting for 45.82% of the total. This reflects the structural composition of the Italian economy, which is traditionally dominated by mid-sized companies that require sophisticated legal support but may lack in-house legal departments fully dedicated to labour matters.

Small enterprises generate 26.73% of labour revenues, while large enterprises account for 27.45%. The relatively balanced contribution of large corporations confirms the importance of labour law in managing complex organisational structures, industrial relations, executive compensation, and international workforce issues. At the same time, the significant share attributable to small and medium-sized enterprises highlights the advisory and compliance-driven nature of the practice, often focused on day-to-day employment management, collective bargaining, and regulatory risk mitigation.

## Areas of expertise and practice specialisation

An analysis of labour revenue by area of expertise reveals a highly diversified practice landscape. Non-contentious and advisory work represents the largest segment, accounting for 24.58% of total labour revenues. This reflects a growing demand for preventive advice, policy drafting, workforce planning, and support in navigating complex employment regulations, particularly in relation to flexibility, remote work, and compliance with evolving labour standards.

Litigation remains a cornerstone of the practice, generating 14.99% of revenues, closely followed by restructuring and reorganisations at 14.50%. These figures confirm the enduring relevance of contentious work and the central role of labour lawyers in managing disputes arising from dismissals, collective redundancies, and organisational change. Industrial and trade union relations also represent a significant portion of activity at 13.12%, underscoring the continued importance of collective bargaining and union engagement within the Italian system of industrial relations.

Other notable areas include M&A and employment-related issues (9.62%) and top management advisory (9.57%), both of which highlight the increasing integration of labour expertise into strategic corporate decision-making. Agency relationships (5.65%), social security (3.75%), and public sector employment (2.07%) represent more specialised but still relevant segments of the market. Niche areas such as sports law (1.76%) and white-collar crime related to employment matters (0.38%) complete the picture, demonstrating the breadth of competencies developed by leading labour teams.

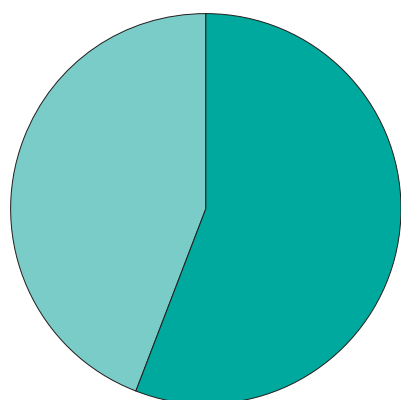

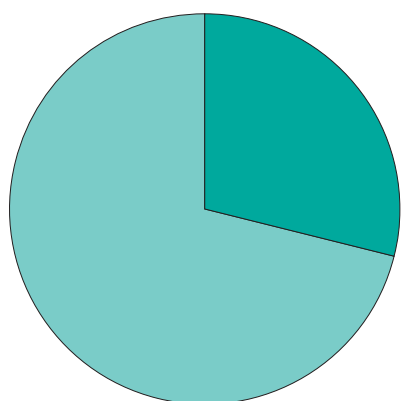
