

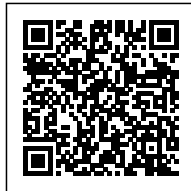
# NLD COUNSELS KOMAX ON SALE TO GRUPO AXO

Chilean law firm NLD Abogados, through its M&A team, has counselled the shareholders of omnichannel operator Komax on the sale of all of the company's shares to Grupo Axo.

The closing of the transaction is subject to the approval of various regulators on the continent.

The firm represented Komax in the jurisdictions where it has a presence, while Ferrere also advised Komax in Uruguay. The firms advising Grupo Axo were Carey in Chile; Creel García-Cuéllar Aiza y Enríquez in Mexico; Guyer & Regules in Uruguay; and Rebaza Alcázar & de las Casas in Peru.
